THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.**

Of my own free will, I agree to enter and compete in a competition or training at Tyrol Basin under the terms contained herein.

I understand that skiing in its various forms, including slalom, giant slalom, and downhill racing, freestyle and mogul competitions, snowboarding, including freestyle, snowcross, big air, and half pipe competitions, and this training/competition involve risks, dangers and hazards that may cause serious personal injury or death and that injuries are a common and ordinary occurrence in this sport and in training/competition. Risks include, but are not limited to, changes in terrain, weather and snow surfaces, ice, moguls, ruts, bare spots, debris, fences, gates, posts, trees, lift equipment and towers, light poles, signs, buildings, roads and walkways, ramps, padded and non-padded barriers and obstacles, half pipes, rails, fun boxes, jumps, and other terrain features both in and out of the terrain park, grooming equipment, collisions with other persons, and other natural and man-made obstacles and hazards. I freely accept and assume the risks associated with skiing or snowboarding in its various forms and this training/competition.

I represent I possess the necessary skills and physical ability to compete in this competition in such a manner that I will not endanger myself, other competitors, spectators or other persons. I understand that as a skier/snowboarder, I am bound by certain Wisconsin state laws and the Skier Responsibility Code (known as Your Responsibility Code). I understand it is my responsibility to inspect the course and terrain prior to competing, to avoid falls and collisions, and to avoid injury to myself and others. I understand I am responsible for inspection and maintenance of my equipment, including skis, snowboards, bindings, boots, poles and restraint devices or leashes. I agree to use restraint devices and/or leashes at all times. I further understand no inverted aerial maneuvers are allowed.

In consideration of the permission to compete in this training/competition at Tyrol Basin and use its facilities, **I RELEASE AND FULLY DISCHARGE Tyrol Basin Corp., its owners, officers, shareholders, agents and employees (collectively the "TYROL BASIN") from any liability resulting from any personal injury to myself, including death, or damage to my property which is caused by the BREACH OF ANY EXPRESS OR IMPLIED WARRANTY or the NEGLIGENCE ACT OR OMISSION of any TYROL BASIN RELEASEE, including any NEGLIGENCE ACT OR OMISSION in:**

- the preparation, organization, coordination, operation or supervision of the training/competition;
- the preparation, design, location, construction, installation, setting, classification, labeling, operation, inspection, maintenance, repair or supervision of the training/competition course(s);
- instructions given or not given to me or any other competitors concerning the training/competition, the training/competition course(s) or any part thereof;
- grooming, snow-making, the operation of chair-lifts, and chair-lift and surface-lift loading and unloading operations for the competition;
- padding or non-padding of natural and man-made obstacles and hazards; or
- posting or failure to post warnings, signs, fences or other cautions or barriers.

I accept full responsibility for any injury or damage which may result from the participation in this training/competition, and I hereby **HOLD HARMLESS** the TYROL BASIN RELEASEES for any injury or damage sustained by me, including death, while participating in this training/competition. I agree not to bring any action or suit against any TYROL BASIN RELEASEE for any injury or damage.

In accordance with Wisconsin law, nothing in this Release of Liability should be construed as releasing, discharging or waiving any claims I may have for reckless or intentional acts on the part of any TYROL BASIN RELEASEE.
